My 2023 Proposed Legislation

HB 1123

Commercial Service Airport Transparency and Accountability

- This bill would allow the 20 commercial airports in the State to conduct purchasing operations with greater flexibility.
- This improves passenger experience and makes better use of staff time.

HB 1049

Boca Raton Airport Authority, Palm Beach County

- This bill would change the airport's classification to local control.
- The bill would facilitate airport operations.
- It also modifies the votes necessary for different items.

HB 979

Dredging and Beach Restoration Projects

- This bill seeks a separate third-party organization to conduct environmental analysis for dredging operations.
- Ultimately to meet transparency and avoid environmental damage.

HB 205

Tax Exemption for Charges for Private Investigations

- Ensures families do not have to pay sales taxes on means to protect their families via small business private investigators
- Investigators in this field are an asset and backup support for police throughout our State.

More of my proposed legislation

HB 851 Disclosure of Grand Jury Testimony

- This bill opens records of grand jury testimonies under certain conditions meeting the public's right to know.

HB 1597 Florida Virtual School

- This bill seeks flexibility for State assessments when it comes to students residing out of state due to military relocation.

HB 569 Pretrial Detention

- Allows prosecutors to hold defendants, no bond when they make particular written threats.
- Expands protections of victims in the case of written threats to kill, extortion, or stalking which are not currently caused for pretrial detention because they are not mentioned explicitly in the law

HB 177 Safe Waterways Act

- This bill aims to Improve communication from departments to municipalities when waters are unsafe for public bathing with the purpose of minimizing exposure to disease.
