The state funds will solely be spent on construction for Blind Pass Road to include the surface, subsurface and infrastructure elements of the project. Infrastructure upgrade to storm water system connecting from state road Gulf Blvd is the most essential element of this project.

Residents, Visitors and Businesses The storm water system upgrades will help alleviate the flooding on Gulf Blvd during major storm events. Gulf Blvd is the singular north to south transit route for St Pete Beach. Approximately 1.2 miles of Gulf Blvd have no bypass outlet and is thus the only road for entry and exit at those points. Blind Pass Road offers an alternative bypass for the northern sector of the City which connects to state road Gulf Blvd at two intersections. The subsurface of the road is currently failed and the road has no sidewalks or bike paths for pedestrian transit. Not only will the reconstruction improve the storm water system, but the redesign improves the safety of the road for both vehicles and pedestrians.
