Breakthrough Miami is a very successful academic enrichment program designed to help talented middle and high-school students from economically disadvantaged backgrounds overcome the racial, cultural and economic barriers to academic achievement. In 2014-2015, middle and high-school students are enrolled at five sites in the 8-year program that guides students from 5th through 12th grade. The program operates on Saturdays during the school year and approximately 6 weeks during the summer. It masterfully engages students in a curriculum that innovatively prepares them for their upcoming school year. Here are a few reasons why we believe Breakthrough Miami is a good partner for the State of Florida in its efforts to bridge its current educational gaps:

A) This scalable program currently serves 1,200 middle and high-school students:

94% of whom are Ethnic/Racial Minorities,

84% receive Free/Reduced Lunch,

47% are from Single Parent Households, and

44% have a primary language other than English.

B) Breakthrough Miami?s results are impressive and are demonstrative of a positive return on investment on the dollars expended through this public-private partnership:

96% of its 11th Graders are taking 2+ advanced classes;

100% of its Seniors are graduating on time from high school;

97% are enrolling in prestigious colleges or universities across the country with 92% having chosen 4 year institutions such as the University of Miami, Florida State University, Florida A& M University, Duke University, George Washington University, Mount Holyoke University, and others.

- C) The student-teaching-students model engages outstanding older students as teachers, mentors and role models in an internship that has been named a Top Ten service learning experience by The Princeton Review. Teaching Fellows are a highly diverse group of nearly 100 outstanding high school senior and college students from Miami-Dade and across the country who are supervised by professional educators on the Breakthrough staff and Instructional Coaches who are certified teachers from public and independent schools.
- D) Breakthrough Miami?s approach and results are based on a scalable best-in-class model. The Breakthrough Collaborative is a national program that ?Launches high-potential, low-income middle school students on the path to college and inspires high school and college students to pursue careers in education. Founded in 1978, Breakthrough Collaborative has changed the lives of tens of thousands of students, utilizing a unique dual mission to:
- 1) Increase academic opportunity for highly motivated, underserved students and put them on the trajectory of a successful college path; and
- 2) Inspire and develop the next generation of teachers and educational leaders.

Nationally, Breakthrough Collaborative has served over 40,000 students and teachers in 27 cities.? So, not only is the program based on a best-in-class national model, it is scalable.

Each public dollar (\$1) invested in Breakthrough Miami is matched by three dollars (\$3) from private sources?foundations, corporations, individuals and independent schools?and is dedicated to providing excellent educational opportunities for motivated students from disadvantaged communities.

With additional funding from the State of Florida, Breakthrough Miami intends to:

- ? Launch additional sites to serve more 270 high-needs students in the Miami-Dade County.
- ? Create a Breakthrough program designed especially for young men to balance the existing program for young women that is already operating.
- ? Strengthen its partnership with Starbots and other strategic partners to leverage its current STEM programming focused on robotics.
- ? Increase the pipeline of talented students from disadvantaged backgrounds to Florida colleges.
- ? Increase Public/Private partnerships in support of disadvantaged youth.
- ? Engage additional outstanding older students as teachers, mentors and role models in an internship that has been named a Top Ten service learning experience by The Princeton Review.

? Launch Breakthrough Florida by expanding to other communities including Broward and Leon Counties: Under consideration is expansion into Broward and Leon Counties where the goal will continue to be to serve a first cohort of middle and high-school students over 80% of whom may receive Free/Reduce Lunch. Depending on the community and its resources, a cohort can range from 90 to 180 students.
