Youth are expected to benefit from increased support in changing their behavior at home and school. Parents are expected to benefit from increased resources and support, which will help them to guide their child who is in the program and other children away from delinquent behaviors.

In addition to the youth and families participating in the program, their communities will also benefit from increased public safety. Completion and recidivism will be reported annually by the Department of Juvenile Justice?s Comprehensive Accountability Report.
