The McNab Road Bridge, built in 1959, is a two-lane bridge structure built over 5 spans which transports McNab Road traffic connecting Cypress Road to the west with Federal Highway (US1) to the east and is located 0.8 miles west of Federal Highway. This structure services both vehicular and pedestrian traffic. The proposed bridge will be constructed over 3 spans. This project entails the replacement of this functionally obsolete bridge in accordance with FDOT's Bridge Management System's ratings. As of 2013 (Broward MPO Level of Service Spreadsheet-2013), the bridge/roadway supports as many as 15,000 daily trips. FDOT?s 2015 annual report recommended replacing this facility immediately to be able to continue to support these many trips and to ensure the safety and well-being of users for another 75 years. Funds are expected to be used for design and construction of the bridge spans. Once built, the City expects to improve pedestrian and traffic accessibility across bridge. The City anticipates the work to benefit scholars and elementary school students (McNab Elementary School is located within a ? mile of the bridge and services approximately 2,000 residential acres), local merchants, visitors, etc. The project will cost the City close to \$6.25 million. If approved, funding is expected to create as many as 300-400 construction-related jobs, but the impact to the community is far greater. Less than 1,000 feet to the west, there are two large shopping plazas and three corner gas stations. East of the bridge, and within ? of a mile, there are another 3 plazas and a major commercial center anchored by Publix Supermarket, Ross, Marshalls, and Chase Bank, to name a few. The supermarket is one of the largest in the area servicing residents as far as Fort Lauderdale, north to Pompano Beach (along Federal Highway), and as far west as Dixie Highway. The canal affected by this bridge connects to the Intracoastal Waterway and traverses as far west as the Everglades running under numerous other bridges! Therefore, the ?act
