This project addresses the need for child representation for abused and neglected children by a Guardian ad Litem as mandated by Florida Statutes. The CRP provides a cost-effective, quality model of representation that serves to provide early and quality representation for all child abuse victims, and utilize experiences and trained child advocates to protect the legal rights of children; something desperately needed with the continued deficiencies within the Child Welfare System and the Department of Children and Families. The full amount of funds requested will defray the cost of salaries and related fringe for 25 GAL employees who will provide advocacy, representation, recruitment and support services for the 11th Judicial Circuit Guardian ad Litem Program.
