Purpose of the Funding:

The requested funding would be used to organize and conduct five one-day seminars that would be open to up to 100 teachers each day. This would include salary for a program director to develop informational materials, distribute the materials to our member private schools and child care centers, as well as following up with personal contacts. Locations for the seminars would need to be found and scheduled, along with needing salaries for trainers.

Our trained teachers would be qualified to interact with at-risk children to affect their quality of life, helping them to be happier and more enthusiastic. CEUs and Master In-service Points will be awarded for teacher participation.
