The \$150,000 will be spent on capital costs to install the three additional bicycle stations. The City?s goal is to ultimately connect to the County?s bike sharing system. The initial target population is the City?s residential population (56,000 residents) to increase the health and wellbeing of the population; however, we are also targeting younger workers as part of our urban health initiative to encourage alternative modes of transportation. This system will supplement our economic development efforts to bring younger workers into the City. Once the eastern Broward County bike sharing system is complete and the City?s program is connected to it, the target population will expand to those covered by both systems, including Eastern Broward County and Fort Lauderdale (pop 172,000).

The City has budgeted \$150,000 in the CIP to fund the first phase of this project rollout for 2015 consisting of three bicycle sharing stations.
