The City of Pembroke Pines has created a program for American Heroes. Our veterans face a shortage of affordable housing, coupled with a severe decline in employment opportunities for our returning veterans. The City of Pembroke Pines having recognized the need has set aside 5 houses on the grounds of the Howard C. Forman health Campus. These homes consist of 5 bedrooms and 2 bathrooms. These homes would provide a perfect opportunity for Veterans and their families to be together and begin the process to mainstream back into the community. These houses are approximately 50 years old and although they are structurally sound, must be renovated to provide a clean and safe home environment. It is also a fact that these homes will need to be furnished.

Utilizing the 2015-16 state appropriation of \$250,000, four of these homes are currently undergoing renovation. The City of Pembroke Pines is requesting \$75,000 to begin and complete the renovation of the fifth home.

As the City of Pembroke Pines completes it renovation regarding R&R Village, the five 5-bedroom homes designated for American Veterans, it is evident based on our research that there is a critical need for payment assistance and supportive staff.

Many of the Veterans that we see are in need of a peer-driven culture in which Veterans can help each other, aided by case managers, clinical staff members and other individuals who can help the Veteran better plan and achieve self-sufficiency.

The City of Pembroke Pines is requesting \$75,000 to fund one full-time supportive staff member and payment assistance for this stage of the Veteran Housing

Project. As we know, permanent supportive housing requires dedicated funding separate from the resource that sustained the original project. This funding is essential for the success of this project.
