The Pinellas Suncoast Transit Authority (PSTA) proposes to connect these key destinations with an enticing new express route designed to serve visitors, the tourism industry and the traveling public. The goal of the Clearwater Beach to TIA Express is to implement a successful new regional service which will provide seamless connectivity between Pinellas County beaches and TIA as well as major employment centers including downtown Clearwater, the Westshore area, and downtown Tampa. Funds requested would be used for operations of the express bus service to match the hours of the airport with trips every 30 minutes from 5a.m. to midnight. The service would also be a prime candidate project for a private operator. While no specific matching funds are being proposed, the tourism development advocates have indicated their enthusiasm through resolutions of support and indication of sharing in costs through advertising.
