The Minneola Green Street project plan represents a combination of low-impact stromwater management with pedestrian streetscape improvements. Facilities would include stormwater plan parking, upgraded streetscaping, and pedestrian and bike paths. The budget for the Minneola Green Street project is \$2.6 million. The project is aimed at improving pedestrian mobility downtown, connecting the uphill downtown core to neighborhoods and Lake Minneola, and providing further enhancement of efforts to clean stormwater runoff before entering Lake Minneola. Construction impacts will create 32 total new jobs earning \$2 million in income and generate more than \$4 million in gross state product. State and local taxes on production solely from construction of the project plan will generate nearly \$90,000. Utilization of the pedestrian improvements are expected to increase mobility and provide enhanced property values.
