The purpose of this program is to assist at risk, low income elders 60 years of age or older, in maintaining an acceptable quality of life in their own home. We provide them with a well balanced home delivered hot meal on a daily basis five times a week. Nutrition is part of the fundamentals necessary to maintain our senior citizens healthy and thereby preventing early institutionalization.

We are requesting \$450,000.00 to serve low-income areas in Miami-Dade County, with emphasis in Central Miami-Dade County. We would expand our program to serve approximately 230 participants and provide them with five days a week hot meals delivered to their homes. We are presently offering our services to 130 participants and have over 100 participants in a waiting list.

With the additional funds we would be able to service an additional 100 low income, isolated elderly participants that are in desperate need of this service. Most our participants are elderly which are frail and are not able to cook for themselves and have no one to help them with this chore. This would give us a total of 230 participants that would be able to receive this service.

Our Case Managers visit each participants home and screen and assess each participant. Depending in their priority needs, ranking and nutritional scores they are then accepted into our program. We provide them with hot meals which are delivered to their homes Monday through Fridays between 10:30 a.m. and 2:30 p.m.
