The Desoto County Jail is an extremely aged facility made up of a portion that was an original building and later expanded in the 70's which results in a number of challenges in its operation. The entire facility is aged and not complaint with current jail standards. The current jail provides challenges in meeting a number requirements in populations including overcrowding, separation for juveniles, sight and sound separation for certain populations and accessibility in accordance with Florida Administrative Code. the Sheriff had communicated concerns of liability due to the conditions of the current facility. In 2011 the BOCC commissioned an independent evaluation of the facility and a cost feasibility study, performed by Clemons, Rutherford & Associates, Inc. The feasibility study clearly identified serious concerns based on code compliance with current standards and operational challenges. A number of options were reviewed to study the costs including rehabilitating the current facility, replacing the facility on the current site, ore replacing the facility on a new site. All averaged 18M. This request would provide the county with funds to acquire property (limited availability in appropriate vicinity) for the jail replacement and provide design and site preparation funding. Once a design is complete, we can move forward in getting true cost estimates and explore financing options for a project of this magnitude.
