Ferndale Preserve is a 196 acre Lake County conservation and restoration property on the western shore of Lake Apopka. The intent of this project is to design and build a one-mile, multi-purpose trail to provide low-impact ecotourism based, public access across natural and cultural site resources from the Ferndale Preserve parking area to the western shore of Lake Apopka. The county is providing funding for additional amenities, ongoing restoration, operations and management. This will provide increased opportunities for ecotourism based recreation in the area along the Green Mountain Scenic Byway and Lake Apopka as well as increased opportunities to develop public appreciation and ownership of natural, cultural, and historic resources with an educational component addressing the conservation and restoration priorities of Lake Apopka and the highlands of the Central Ridge. The general public and those interested in passive outdoor sporting activities will benefit from the receipt of these State funds. Also, should funding be received, the Lake County Needs Assessment and the adopted countywide Parks & Recreation Master Plan will be used to measure performance data.
