\$170,000 of general revenue will fund two full-time coordinators and operating expenses for the Donated Dental Services (DDS) Program through the Dental Lifeline Network. These coordinators will facilitate appointments for comprehensive dental treatment between those indigent Floridians who are disabled, elderly, or medically fragile. In 2014-2015, 210 patients received \$860,560 of treatment. Each patient treated (with the exception of the 32 patients receiving ongoing maintenance services) received an average of \$4,403 worth of dental treatment. Floridians who are disabled, elderly or medical fragile will benefit from this program. Additionally, the program will help reduce costs in emergency room settings, which is typically where these individuals end up if they can?t get access to a dentist. A program summary report and financial report for the fiscal year will be created to document performance data for the project,.
