Florida institute of Technology is a private, not-for-profit, STEM University. The Academic Program Contract funding allows the university to provide financial assistance to Florida Residents to pursue degrees in STEM. In FY14, Florida Institute of Technology received \$1,000,000 from the State to provide this assistance to students. 170 students received an average award of \$5,882 through this program and the average GPA of the award recipients was 3.22. 30% of these funds were awarded to female students, an ?under represented? group in a STEM field. 44% of the receipts of these funds were first generation baccalaureate degree candidates. Additionally, 16% of the receipts were minority students from 29 counties in Florida. 100% of the funds were used to provide direct financial assistance for students. Florida Institute of Technology is requesting these funds to allow this program to be reestablished.
