The new legislation is a comprehensive environmental stewardship bill, the ?Florida Keys Stewardship Act? that expands the current Mayfield Act State funding authorization (\$100M remaining) to more comprehensively support and advance the legislative requirements and intent of the Florida Keys Protection Act which designated the Florida Keys as an Area of Critical Concern, through: (1) a 10-year annual appropriation of \$20M to help address water quality issues including wastewater treatment implementation, storm water implementation, and restoration of poor water quality canals (to be matched by local effort) and (2) a 10-year annual appropriation of \$5M in Florida Forever funding to help address the acquisition of vacant parcels for the purposes of protecting critical habitat, public safety, and property rights (to be matched by local effort). Multiple Subdivisions in the Florida Keys will receive funding through this program including, Monroe County, the City of Key West, the City of Marathon, the City of Key Colony Beach, the City of Layton Islamorada, Village of Islands, and the Key Largo Wastewater Treatment District.
