This is a career and educational enhancing experience that engages students and communities in activities that teach and demonstrate the importance of the military to our survival as a Democracy. The Florida Living History Civil War Reenactment Unit will coordinate the 3 year ?road show? highlighting Black military involvement during the Indian Wars, Revolutionary War, Civil War, WWI, WWII, Korean, Vietnam, Afghanistan and Desert Storm. Major wars the U.S. fought will be represented through period clothing, banners, equipment, exhibition, a curriculum based lesson plan, brochures and a teacher guide. Students will be included in reenactments and related activities. The Florida African American Heritage Preservation Network (with over 30 cultural and heritage member organizations) has a history of planning and developing heritage education programs. The Network will provide the framework for this project?s coordination and promotion of living history presentations. Funding will provide stipends to 2 coordinators \$40,000; special subject area consultants \$15,000; acquisition of additional period clothing and artillery \$18,000; college student interns and adult re-enactor stipends \$32,000; and \$61,000 for planning, project management, web site development and annual evaluation. Each year 100 youth will be used in reenactments; 12,000 taught through curriculum based school programs; over 25,000 attend living history presentations, and a web presence for expanded viewership.
