Florida's K-12 education facilities funding mechanism is based upon the ad valorem tax. It assumes a District's land values will produce the needed revenue to provide education facilities for that school district's student population. This approach is sound in almost all school districts. However, in a small number of districts, relatively low land values coupled with the extremely high student growth rate results in a shortfall of capital needed to meet the district's student station needs.

The Legislature has recognized this aberration by enactment of Chapter 1013.738 High Growth District Capital Outlay Assistance Grant Program in 2005. This funding formula measures ad valorem land value, growth rate, and local effort which results in identifying districts which are unable to afford necessary student stations for their student population.

The Legislature provided high growth grant money to such districts in 2002,2003 and 2005. The downturn in the economy retarded growth throughout the state ending the immediate need to find the program. With the resurgence of the economy, some district are again unable to provide needed student stations due to the rate of growth and low revenue producing ad valorem values.
