\$675,000 will be spent to support operating supportive service for adults with intellectual and developmental disabilities at Loveland Center, Inc. More than 130 individuals currently participate in Adult Day Training, Supported Employment and Support Living Services through the organization. Loveland Center will be opening the Loveland Village, apartments for adults with intellectual and developmental disabilities that will provide an affordable and supportive housing option. \$1,000,000 will be spent toward the construction of an additional student service building to provide the need for additional space to serve current and new students in need of supportive services by the organization. A state appropriation will be leveraged through a capital campaign with the community and additional funders. Through the requested funds, Loveland Center can expand the operations of an innovative adult day training program focused on promoting independence and self-sufficiency amongst adults with developmental disabilities. Additional classroom space would also increase the educational opportunities available. A minimum of 130 adults will receive innovative adult day training services. A minimum of 25 adults will receive supported employment services. A minimum of 60 adults will receive affordable housing and supportive services.
