PHSC has continued to grow over the past 8 years, realizing a growth of over 40% in full time enrolled students. Though the College continues to increase the use of on-line services for advising, there is still an increasing demand for live, one on one advising and other student support services. The College is requesting funding to help create a physical environment that is more conducive efficient student support and learning. We are requesting the following:

\$2,551,797 in planning funds for the "Remodel of West Campus Buildings A thru E with addition and chiller plant expansion." The total project was estimated at \$51,077,052. The primary purpose of this project is to enhance and expand student service support space to meet increasing demands. Support services include Admissions/Records, Student Development and Veterans' Services, Career Testing and Placement, Disability Services, Financial Aid, and Student Activities. This project will include the remodeling of 8 computer labs to increase student access to digital resources and a new facility for district operations.

PHSC has received no renovation and remodeling funding for the past three years.
