The City of Parkland is seeking financial assistance with the costs of roadway improvements in the portion of the City known as ?Pine Tree Estates?. Pine Tree is one of the older communities in the City and includes roughly 911 acres. It is comprised of single family homes on lots ranging from 1-3 acres in size. There are 22 roads within the area which exhibit a number of irregularities and deficiencies due to age.

Although property owner?s rights extend to the centerline of the roadway, the community has no homeowners association. Efforts to organize the area to complete the needed roadway work, to date, have failed. The City is requested funding to restore the existing 18? wide rural roadway (no roadway widening is planned). Many of the roadways in this area are ?dead end? with alternative access for emergency vehicles.

Upon completion of the badly needed resurfacing, the City will provide for future maintenance. Successful completion of this project will ensure safe roadways as well as assuring future maintenance. The City will fund any remaining balance.
