The Public Defender's Office, 6th Judicial Circuit, has operated a successful ?one judge/one child/one attorney? approach since 2006 and requests \$400,000 and positions to expand its resources for cross over children. Specifically, there is a need to enhance and develop diversion options from DJJ for crossover children and need to develop pathways to more services. There are a number of children ?aging out? of foster care who need continued services and housing options. The Spring 2014 survey conducted by the Florida Department of Children and Families found 40% of survey respondents aged out of foster care without a diploma or GED; 67% of the respondents had not held a paying job in the last year. Attorneys would also assist appropriate ?dual status? youth with sealing or expunging delinquency records to assist with future education and employment opportunities. The Public Defender?s Office, 13th Judicial Circuit, requests \$600,000 and 4 positions to begin a similar pilot project for Hillsborough County youth. In its first year of operation in the 6th circuit (Pinellas), Public Defender Crossover for Children?s program provided representation in over 400 delinquency and dependency cases to over 100 children. Based on our similar populations and issues, the 13th Circuit anticipates similar volume for the first year in Hillsborough
