This funding request is for the design and construction of a new animal control shelter in Putnam County. The current shelter is antiquated, undersized, poorly located and inadequately designed. This new shelter will provide a proper lobby/reception area for the public plus an appropriate intake area adjacent to veterinary space. There will be a separate area for cats as well as separate kennels and runs for dogs. The facility is being relocated to a higher visibility area offering increased accessibility to the public to promote adoption programs and increase cooperation with those involved in animal protection and rescue. None of the requested funding will be used for positions or associated salaries. The new facility will address citizen demand for better conditions for housed animals as well as space for medical treatment of the animals.
