This funding will help to restore the William Weech American Legion Post 168 in Key West, Florida. This building is a historic resource and landmark with great significance to the African-American community. It was constructed after World War II, at a time when segregation was rampant and its members were not allowed to join the all white American Legion post, so the members formed their own post and constructed this facility. The building is currently listed on the National Register of Historic Places. In addition to its ties to the African-American community, the building's Art Deco stylistic detailing is relatively uncommon in Key West and represents an architectural style worthy of preservation. The funding will be used to install code compliant plumbing and electrical systems (\$66,000), construct ADA compliant restroom and ramp (\$40,000), and install a mechanical air conditioning system (\$48,000). With these tasks completed, it will be possible to re-open the facility for use by the American Legion and the community. Future project phases will provide a fully restored building, returned to its historic configuration dating back to the early 1950s.
