What local/statewide interest does this project address: Preservation of Florida's maritime heritage and attracting visitors to Wakulla Co. and the entire Big Bend area. Visitors will require gas, food and lodging and are likely to increase attendance at nearby historic sites and state parks, generating a significant economic return on investment.

Measurable Outcome Anticipated: 36,000 - 40,000 additional visitors to the lighthouse each year based on comparable lighthouses. Each \$1 spent on St. Marks National Wildlife Refuge entrance fees is multiplied 10 times in the community according to a 2010 USFWS study. The Refuge currently hosts 250,000 visitors per year.
