In 2012, Sarasota successfully piloted a summer program for entering kindergartners and their families at one elementary school using funding from the Community Foundation of Sarasota County and private donors. The Eagle Academy at Alta Vista Elementary is a two-generational approach to closing the achievement gap, preventing summer learning loss and improving school-family connections. It is well-documented in current research that low-income children can experience summer learning losses of over two months in reading achievement, which can result in being severely below level by the time they enter third grade. Students in the Eagle Academy attended a seven week instructional and enrichment program and, as a result, did not experience the summer reading loss. Student achievement data reflects increased performance from the Eagle Academy participants when compared to non-attending students: Kindergarten children who attended the summer Eagle Academy showed 22% great proficiency on a kindergarten readiness test over non-attending kindergarteners. Each year since 2012, first through third graders were added to the summer program.

To support and improve school-family connections, parents attended weekly Parent University evening classes. Also, the families from this high-poverty school (92% free & reduced lunch) benefitted from the support of a social worker, which was funded by private donations.

The purpose of this request is to continue to support the Eagle Academy at Alta Vista Elementary for entering kindergartners through third graders and to expand this summer learning academy to three other Title I schools whose Free & Reduced Lunch rate exceeds 88% (i.e., Emma E. Booker Elementary, Gocio Elementary, and Tuttle Elementary). This appropriation would support the fiscal year expansion in July-August of 2016 and June of 2017 for incoming kindergarten and first graders.
