Founded in 1952, the Central Brevard Humane Society (CBHS) is Brevard County's oldest established animal welfare organization. A ?no kill for space? shelter, CBHS is dedicated to speaking for those who cannot speak for themselves. We house and care for approximately 2,000 animals annually, with 1,800 finding their fur-ever homes.

The large dog kennel area is 3,500 s.f. with 29 kennels for large dogs. The kennels in their current condition are requiring constant repairs and are in dire need of a total replacement. The CBHS experienced an incident in the past with a large dog that had 24 hours a day to think of ways to escape its confines. Unfortunately, this dog found a way into a ?patch? repair and came to an untimely death from being hung up in the fencing. This event extremely devastated our staff and we have vowed to do whatever it takes to ensure that this does not happen to any other animal in our care. However, due to funding, we only have a budget for repairs versus replacement. Our hope is to provide new state of the art kennels with large glass doors for better viewing for and of the dogs.
