Medical staff provide psychiatric care, basic health status checks, and work with the family to maintain linkages to community health care practitioners. The entire family is embraced in care, and family commitment and participation is essential and expected. The CAT Team assists the family in developing a natural support network, improving interactions with the school system, and developing and using other community resources and supports.
