The South Florida Water Management District has been upgrading the C4 Basin Canal. In order to do so, the SFWMD has had to reclaim its right-of-way(s) which extends up to thirty (30) feet North of the canal. In doing so, many neighbors' fences have had to be removed. Residents and constituents have been left without any recourse as to the rebuilding of their fences, and this money would be used by the Water Management District to reimburse homeowners for the costs of replacing or re-installing their fences, up to \$2,000 per home. There are approximately 250 homes impacted, thus the \$500,000 estimate. These monies would also be used to send proper notice to residents to inform them about this program.

The people that live up and down 8th Street on this very important part of Miami-Dade County. These are middle class homes and the people that live there cannot afford to put up the fences that the Water Management District Put Up. At the end of the day, the district is a creation of the State and these residents are looking to the State of Florida for an answer.
