Students in the State of Florida who have been deemed eligible for homebound or hospitalized program services are considered students with a disability (In accordance with Section 1003.01, Florida Statutes). These students are entitled to a free appropriate public education, defined by the US Dept. of Education as including programs designed to meet their individual needs, equal quality of services to those provided to non-disabled students, teachers trained in the instruction of individuals with disabilities and comparable facilities and materials.

As one of only three statutorily defined children?s only hospitals in Florida, All Children?s Hospital Johns Hopkins Medicine is dedicated to caring for the state?s sickest children. We provide access to over 50 pediatric specialties, and are the most advanced children?s hospital on Florida?s West Coast. All Children?s is the state?s highest provider of Medicaid services, with approximately 70 percent of our patients benefitting from Medicaid, many because of the severity of their illness. Last year, we performed more pediatric heart transplants and pediatric bone marrow transplants than any other hospital in Florida. Our population of patients additionally includes children with chronic illnesses such as cystic fibrosis, neurological disorders, congenital heart disease, kidney disease, cancer, and sickle cell. In treating very sick children, the length of stay for patients in our hospital is significant. Our patients may be in our hospital for weeks and months at a time, or several days in frequent spurts throughout the year depending on the illness. Last year alone, we had more than 2,400 students qualify for hospital homebound services due to their illnesses requiring lengthy or frequent hospital stays.

Unfortunately, children and youth suffering with acute and chronic illnesses and who are hospitalized for extended periods of time are not receiving adequate educational services, and have limited continuity of instruction: leading to apathy about school, frustration within the family, decreased quality of life, and

decreased graduation rates. Students may enroll in their county?s hospital homebound program, Florida Virtual School, transfer to the Pinellas County school district, or a family can choose to home school. Each of these choices has limited ability to meet the individual learning needs of many students. The current system leaves many of our patients with poor academic outcomes, often leading to retention and drop out behaviors.

School districts outside of Pinellas County are often not able to provide a teacher to travel to All Children?s to provide educational services per the current hospital homebound system. The choice of Florida Virtual School is a difficult situation for a child who is ill. Daily hospital treatments and illness leave patients unable to predict their ability to work on and complete assignments. The process to transfer between counties in order to receive educational services within Pinellas County is burdensome. To better serve ill children, All Children?s hired its own teacher to provide services to our hospital homebound patients.

Additionally, because the student population census for school district funding is only done twice per year, funding for hospital homebound services is not adequately following the student when they enroll in Pinellas County schools, leaving the school district without the appropriate resources to provide a certified teacher for the hospital. Last year, approximately 2,400 patients at All Children?s qualified for hospital homebound services. However, due to limited resources and complications within the current hospital homebound process, our in house teacher at All Children?s was only able to reach approximately 500 students, leaving a significant number of sick children without needed educational support.

All Children?s seeks State funding to improve educational services being provided to hospital homebound patients. By providing funding directly to All Children?s in support of patient academic services, we believe this population of hospital homebound children can better be reached. These funds would directly support the hiring of two additional certified teachers hospital to be based at All Children?s Hospital. We believe that with the addition of two more teachers dedicated to teaching hospitalized children, we can provide greater continuity of education of this population of students. Hospital based teachers will allow for All Children?s to provide personalized educational services suited to this unique student population, who have variable schedules due to their clinical needs and are coping with the stresses of pediatric disease, often traveling great distances to receive treatment at All Children?s and missing valuable school days during recurrent or lengthy hospital stays.

The expected outcomes will be improved educational successes of students with acute and chronic conditions. By providing increased support of hospital homebound services at All Children?s we will be able to reduce the gap in services, provide continuity of educational services for this population of students throughout all counties, and maintain uninterrupted instruction. Additionally, these children will be better prepared to thrive into adulthood and become future citizens that support the economic vitality of Florida.
