Additionally, the course measures students? attitude toward hazing and knowledge of the subject prior to and after taking the course in order to assess its efficacy. The course serves as an important education and prevention tool for the entire student population entering the SUS and is the cornerstone of an overall hazing prevention strategy for the state. Among the benefits to the state are that it helps make Florida universities safer places for students to learn, helps prevent tragedies, such as the Robert Champion death at FAMU, and demonstrates that the state is taking affirmative steps to prevent hazing related injuries and deaths.
