Sertoma Speech & Hearing Foundation has been paying for these tests since 2000 for non-Medicaid, uninsured, and underinsured patients. These diagnostic evaluations which range in cost from \$475 - \$7500 are important to the baby?s development. The results of the program funding will ensure that 120 children who are deaf will have the required testing and evaluation required to meet the states goal of amplification and entrance into a public or private program for educational rehabilitation and language development (either signed or spoken) by six months of age.
