Anchorage Children?s Home seeks \$50,000 partial funding to continue Street Outreach & Recovery (SOAR) serving homeless youth in Bay County. SOAR identifies and connects homeless youth to survival aid such as food/water, hygiene supplies and access to safe shelter/housing. The closest SOAR Program is Jacksonville, FL so services are needed and not duplicated. Homeless youth often engage in self-destructive behaviors in order to survive such as exchanging unsafe sex and illegal means for food, clothing and shelter becoming vulnerable to traffickers, diseases, trauma, illness and physical/mental health issues often leading to long term conditions requiring treatment at the taxpayers? expense. Bay county & taxpayers will benefit from the program effectiveness in diverting homeless youth from illegal activities to positive ones. Few legal opportunities to generate income, homeless youth often turn to illegal means and end up being arrested or detained. They also face numerous barriers when it comes to accessing education, job skills/opportunities, transportation, etc. Without academic and vocational training, self-sufficiency is unrealistic and improbable. SOAR puts resources in place allowing homeless youth opportunities to end homelessness and generate a beneficial investment in our community as a whole. The SOAR team served 100 homeless youth in 2015 and anticipates the same for 2016. SALARIES: \$17,273.70; OPERATING: \$3160.00; DIRECT CLIENT NEEDS: \$29,566.30=\$50,000.00
