This request is for a portion of capital costs associated with the acquisition and installation of a regional P25 800Mhz land-mobile public safety radio system to serve the citizens of Manatee and Sarasota counties. This funding reduces the needed local funding and associated debt service for the public safety project.

Total system capital costs is \$28.4 million. Manatee County's portion is \$14.7 million; Sarasota County's portion is \$13.7 million. The matching funds are being provided by each county such as Surtax III proceeds.

This system will provide potential connectivity to the State Law Enforcement Radio System (SLERS) once upgraded to the P25 compliant standard. It is anticipated that there may be some additional infrastructure to connect the systems depending on the SLERS project scope and implementation. It is important to maintain collaborative efforts between the State and the Suncoast Regional Communication System team to ensure SLERS connectivity is achieved.
