The funding would go towards the TFLA summer jobs program, and would be used for salary for 285 students; payroll taxes; transportation; training for students; administration; background checks; staff services and resources; miscellaneous costs (t-shirts, foods, supplies. Expected benefits includeincreased skills for nearly 300 students, for many of whom TFLA is their first job. The funding will allow us to greatly expand the summer jobs program to allow students an opportunity to experience what a future in a professional setting can be, and offers them the opportunity to gain important skills and training. Additionally, summer jobs programs have been shown to significantly reduce violent crimes, and literally save lives. We are hopeful that TFLA will have a long-term impact on the violent crime rate in Tallahassee; and in the short-term reduce the youth crime rate, especially in the summer months when the program is active. The student participants will certainly benefit from gaining skills and training, and also from having a meaningful work experience. The greater Tallahassee area will benefit from having a large crop of talented youngsters who understand that they have a bright future ahead of them. They represented a better trained workforce; which will, in turn, lead to economic growth for area businesses.
