The Florida International University Herbert Wertheim College of Medicine FIU Health Care Network in partnership with Nicklaus Children's Hospital will provide student health services to the 54,000 students attending FIU through the use of telemedicine. Research supports the use of telemedicine for the college-aged population. The millennials are the right population to embrace telemedicine and its use can lower costs while enhancing quality of care, access, health outcomes, and consumer satisfaction.

FIU will work with Nicklaus Children;s Hospital, which has an existing telemedicine program, to purchase and maintain medical pods for use on FIU's Modesto Maidique Campus. The medical pods and other technologies will provide 24/7 convenient access to services to students. In addition to the purchase of the medical pods, the funds will be used for operations including providers, faculty time, other equipment purchases, and maintenance.

Since students must pay a health fee, the use of telemedicine will:

- > assist in containing costs so health fees will not increase
- > increase quality of services in students
- > Increase student satisfaction of services provided

Better access to healthcare for students will:

> enhance student performance by promptly providing services so the student will have minimal or no loss of class time

>reduce student absenteeism

FIU has already compiled significant data on FIU's student health services to include utilization rates, provider level of service, volumes, cancelled appointments and missed appointments, and reason for visit. After the introduction of telemedicine, FIU will be able to evaluate the impact on student health services and share findings with other State Universities.
