Terry Street Bicycle & Pedestrian Improvements: This project is for the design and construction of bicycle and pedestrian improvements along Terry Street. Specific project components include the construction of dedicated bike lanes, a sidewalk along the south side of the roadway from Bonita Springs Middle School to Old US 41, and a pedestrian bridge across Rosemary Creek. The project will significantly improve bicycle & pedestrian connectivity along the Terry Street corridor, which connect two of the primary arterial north-south roadways in the City: US 41 and Imperial Parkway. A large number of Bonita Springs elementary students live just east of Terry Street?s intersection with Old US 41 and use the corridor year round to access not only the middle school, but the City?s Recreation Center, Skate Park, Little League fields and Library which are all situated adjacent to the middle school. Additionally, the intersection of Old US 41 and Terry Street is the northern gateway to the City?s historic downtown, which currently is undergoing an \$18 million renovation to spur economic growth and revitalization. In Summary, this project will make what has been historically an inherently unsafe, heavily used, pedestrian and vehicular corridor a safe and functional amenity to the community.
