They have formed an alliance with the Vero Beach Power Squadron and Costal Conservation Association for placement location, placement, and permitting of the mats/ bags. The goal of this project is to help restore the Indian River Lagoon and employ individuals with developmental disabilities.

### Help restore the lagoon:

We all have a vested interest in restoring the Indian River lagoon, the largest estuary in North America. Oyster mats are a proven tool in the restoration effort and are relatively simple and inexpensive to make. Oyster factoids:
