Both curriculums developed with the Small Business Development Corp SBDC.

An on-line business curriculum for distance learning where individuals acquire and improve their business acumen, available statewide. Users can develop and write a business plan for an existing or new childcare site as related to population they intend to serve, determined the impact of subsidized child-care, co-plays, enrollment ratios, and VPK to set realistic fees. Included are key licensing requirements focusing on importance of compliance not only related to delivering quality childcare but the impact noncompliance has on revenues. Also business skills and marketing strategies based on their business operation and the revenues they need to generate in order to offer quality childcare.
