The Washington Center's academic internship program provides Florida public university students with the opportunity to intern in Washington, DC for academic credit during fall, spring or summer terms.

Students from all 4-year public institutions in the State University System are eligible. Students intern 4 days per week during 10-week summer or 15-week fall and spring terms and may work at a number of institutions including non-profits, businesses, Capitol Hill or federal agencies. One day each week is reserved for civic engagement and leadership activities. Students also take an academic course and receive a guaranteed housing. The program is made up of a diverse group of students, 45% of whom are U.S. minorities or foreign students.

State funding provides scholarships for students, many of whom would be unable to enroll in the program without significant funding. The scholarship level is currently set at \$7,000 per student, and the Washington Center matches \$1000 per student for each award given by the state.
