All work program elements will be contracted out, therefore, City of Treasure Island will absorb all costs related to City personnel oversight, preparation, assisting contractors and subcontractors. Amount Requested is for: i. Rehabilitate Hydraulic System Components of the Bascule Bridge including pumps, hoses, tanks and filters: \$225,000 ii. Rehabilitate major electrical components including switchgear, motor starters and backup generator: \$152,000 The City of Treasure Island will continue to absorb the ongoing daily cost for staffing, operating and maintaining the Causeway bridges and roadway which is currently budgeted at approximately \$595,000 for FY 15-16. The 2014 annual average daily traffic (AADT) count for this corridor was 18,824. The most recent traffic count for the three days ending 3-3-15 was 22,848. According to a comprehensive O & D study performed in 2000, approximately 40% of the traffic is through traffic with an origin and destination outside of Treasure Island. Finally, this Causeway Corridor serves as the Hurricane Evacuation Route for Treasure Island and parts of Madeira Beach and St. Pete Beach.
