It is not anticipated that any further appropriations will be requested in the years beyond 2016-17 if the requested additional recurring funds of \$500,000 are appropriated in 2016-17. USF St. Petersburg?s Vision 20/20 Strategic Plan and the 2015 Work Plan include two important goals: 1) Student Success and Culture, and 2) Faculty Excellence in Teaching and Research. Central to achieving these goals is providing the best instructional experience for students. This new initiative will create a Center for Innovative Teaching and Learning (CITL), which will be committed to the advancement of teaching and learning at USFSP. The CITL will be a resource for the academic community by offering a wide array of research-based programs and services that support teaching and reflective practice. The CITL will train instructors on new digital technologies and innovative instructional practices that focus on student learning, developing critical thinking skills and designing outcome assessments to measure success.
