According to U.S. Census data, Wakulla County?s population has grown from 22,863 in 2000 to 30,776 in 2010, an increase of 7,913 or 34.6 percent, making it the 47th most populace county in the State. Wakulla County is considered a fiscally constrained county and received a Rural Area of Opportunity (RAO) designation in 2011.

Crawfordville has very old and separate Fire and EMS structures serving the Crawfordville area. None of the existing structures are adequate to house full-time or volunteer fire/rescue/emergency medical response personnel, emergency vehicles and associated equipment.

The Fire Rescue administrative office is located on Trice Lane and is prone to flooding during rain or storms. The EMS station, next door to the administrative office, does not provide proper or adequate parking bays and ambulances must park on unpaved, uncovered and unsecured areas. It lacks adequate or appropriate guarters to house fire and emergency medical personnel during shifts.

The Fire Station located on Cedar Avenue, has inadequate space for emergency vehicles and staff. The area has grown into a residential neighborhood and there are two heavily used County parks situated on both sides of the exit to U.S. 319, creating safety hazards for pedestrians, vehicles and Fire personnel.

Three years ago it became necessary to move the career firefighters from the Crawfordville fire station due to unlivable conditions. The staff and equipment are now housed in the only classroom at the WCFR Training Center, which is next to the Wakulla Sheriff?s Office. The classroom was converted into living quarters

that is far from suitable for this occupancy. County wide fire training is now held in a fire station creating a less than ideal situation for training, housing or administrative activities.

To better serve citizens and visitors; increase safety; provide an adequate, secure and covered location for expensive emergency equipment and vehicles; expand coverage area; and, improve conditions for fire and emergency personnel the County is in desperate need of funds to consolidate the Fire and EMS stations into one location. Wakulla County does not have the financial resources, expertise or staff to design or construct a much needed consolidated Crawfordville Fire and EMS Station.

Growth in the County is concentrated in the Crawfordville area placing even greater demands on an already strained fire, rescue and ems program. Funds are being requested for a new, consolidated Crawfordville Fire and EMS station on Trice Lane that will be approximately 8,000 square feet. Estimated Project Cost: \$2.0 million for design and construction.
