The City of Hialeah Gardens is requesting \$600,000 in State funding to replace the community pool at Westland Gardens Park. The pool was constructed in the late 70?s to early 80?s by a private club; the City purchased the park in the mid 90?s and has offered swimming classes since.

The pool was repaired in the late 90?s and again in 2004. In March of 2015 the pool was closed once again, due to structural damage on the deck and walls. In as much as repairs could be implemented again our Engineering department is recommending full reconstruction due to the repeated structural failures which arise out of improper preparation of the underlaying soils.

The proposed reconstruction will demolish the existing pool and deck remove and dispose of all unsuitable underlaying materials, back fill with structural, compactable material and reconstruct the pool, bringing everything up to current codes and standards.

The existing pool which contains 115,000 gallons and varies in depth from 3?-0? to 6?-0?, will be replaced with a similar size pool, but will keep the deepest depth to 4?-0? in order to accommodate younger swimmers. The City estimates the cost of construction to be \$600,000 including Engineering, permitting, construction, inspections and certification. With a 12month construction timeline, the pool will be available to the public by the summer of 2017.
