Four current statewide programs will be strengthened, expanded, and more accessible throughout the state: Careers in the Arts and Creative Industries for Students Looking to Go into Training and Future Careers, securing exemplary art, music, dance, theatre, film, etc. lesson plans for access to educators on the C-Palms Program Web site, development of the Florida Arts Model School Program throughout the state, and the development of a statewide strategic plan for greater access for all students throughout the state to arts education opportunities in collaboration with the four statewide arts education service organizations that involve music, dance, theatre, and art. This is a request to restore Florida's investment in these statewide arts education programs to the level it was before the recession hit the state. This collaboration between FDOE and Arts for a Complete Education/Florida Alliance for Arts Education was established in 1989.
