This project will provide for the design of an environmental center, improved parking lot, and site work. All of the \$200,000 requested, plus the \$200,000 from the City of Cape Coral, would cover the design costs (Phase I of the project.) Sirenia Vista is an 8.4 acre parcel. Manatees congregate in the canal system just east of the property. The City has worked with the Lee County Tourist Development Council for shoreline improvements and creating areas for observing the manatees. Services provided through the environmental center will include classes for all ages, educating them on environmental issues in general and, more specifically, manatees. The target population for this project would be tourists, residents of Cape Coral and visitors from within Florida, particularly the surrounding counties of Charlotte and Collier. Funding for construction costs may be requested from the state in future years.
