Funds will be used to purchase security cameras, computer hardware, specialized software equipment and specialized training for the specified department members to maximize efficiency in the forensic examination of these devices.

This project will upgrade public safety technologies allowing the Coral Springs Police officers to solve crimes more efficiently and ensure a reliable security system in our parks. A Hi-Tech Forensic Analysis Unit will be used to analyze computers, communications devices, and/or data storage devices that are used to commit crimes. Law enforcement agencies must have the capability to analyze these devices in a timely manner in order to observe, retrieve, preserve, and present the evidence contained within them. Providing security cameras in our parks will enhance the perception of safety for all visitors at our parks while preventing burglaries.

The City will match over 100% of State funding in the amount of \$80,500 to complete the total \$161,000 project cost.
