The current drainage systems do not sufficiently discharge of storm water, nor do they remove pollutants before the storm water is discharged into the Lake Worth Lagoon. The project will include the installation of new drainage structures that will remove storm water from residential areas. The project may also include a component that addresses water quality if storm water runs into Lake Worth Lagoon. The water quality component, though yet to be determined, will clean storm water prior to its discharge into Lake Worth Lagoon. This project will help to decrease nuisance flooding and beautify Lake Worth Lagoon, which surrounds vacation rental properties. This project is shovel-ready to begin work within six months.
