The City of West Park adopted the McTyre Park Master Plan. This project consists of design and construction of a Multi-purpose Center on the 18.4 acres of Public Park. The multipurpose center will house three multipurpose courts for basketball, tennis, volleyball and other activities. This new facility will create much needed jobs for the surrounding community. The plan was approved by the City Commission with input from the community. Funding will be used to directly fund Phases I-III of McTyre Park Cultural Center's Construction. The City of West Park has already developed a Master Plan for this open/green space, public facility. The project has the capacity to build-out for multiple, multi-use facilities. This project will accommodate parking, building, classrooms (multi-cultural, cooking, dance, theatre auditorium, etc.) and more. Residents, local artists, businesses and elected officials are in full support of this project. We anticipate this project will benefit this low-income community with gainful employment opportunities (permanent, temporary, skilled and unskilled, teaching, clerical, etc.). In addition, property values will increase as a result of the construction. We anticipate this project benefitting 14,156 residents (children, men, women, seniors), and 60,000 guest visitors.
